- Hobbytex's regular terms of sale may not be varied by me and I have no authority to enter any contracts or arrangements of any kind for or on behalf of Hobbytex other than to solicit and accept purchase orders for Hobbytex's products.
- No purchase, other than the New Distributor Kit, is necessary to become a Hobbytex Distributor. I am not required to make any financial investment to become a distributor. I am not required to maintain an inventory.
- This distributorship may be terminated at any time upon written notice by Hobbytex or by me.
- Hobbytex Pty Ltd may terminate my distributorship without notice if I discredit the Hobbytex name, fail to comply with any of the requirements of the sales plan, misrepresent Hobbytex's products by making claims contrary to the product literature and labels, or for any other conduct which may seriously affect Hobbytex's business or reputation.
- This agreement shall be governed by the laws from time to time in force in the State of New South Wales.
